By reaching children at an early age and providing safe, positive activities and encouragement, our Club provides a compelling alternative to youth crime, gang membership, drugs, and other negative influences that effect our youth today.

Our Club is a safe and stable place that ensures the physical and emotional safety of young people by promoting their development and instilling a sense of competence, usefulness, influence, and belonging. When this strategy is fully implemented, self-esteem is enhanced and an environment is created which helps our members achieve their full potential.



### **HISTORY**

The Boys & Girls Club of Allentown was founded in 1937 and was located on Ridge Avenue.

In 2002, the Girls' Club of Allentown merged with the Boys Club of Allentown. With compatible missions, the Board of Directors of both organizations believed that a merger and combined resources would provide many exciting opportunities for our community's youth. The original Girls' Club site at 13th and Turner Streets remained a girls-only facility until 2014.

As the combined Boys & Girls Club of Allentown (BGCA) found its program niche, the youth living in the city of Allentown benefited greatly from the experienced staff and leadership.

While the world continues to change, the issues that our youth and their families face remain the same. All kids in Allentown need access to a safe environment that offers educational and fun activities. We are proud to have served our members continuously though the pandemic!

## MESSAGE FROM THE CEO

Throughout 2020-2021, our world continued to evolve as it kept pace with COVID-19. In the new normal at BGCA, we discovered how to adjust our programs and services in a safer and more socially-distant manner. We even offered a Virtual Learning Center for Allentown School District students who were unable to attend school in person. Our staff worked with a core group of children daily at the Sixth Street Clubhouse from 7:45am to 3:00pm so that they could be successful in school while utilizing our internet and other school-supply resources. These students not only thrived but surpassed their peer groups who were working virtually at home!

As the year progressed, BGCA staff and members learned how to remain flexible, pivot as needed, and improve program delivery. We even began a new Hydroponic Gardening program thanks to Fork Farms and Boys & Girls Club of America. Our members learned how to grow lettuce and basil indoors by utilizing a new hydroponic garden system that cultivated year-round vegetable growth without the use of soil. These vegetables were supplemented with tomatoes, cucumbers, corn, and peppers grown in our small outdoor garden. Not only were our kids proud to grow veggies, but they delighted in sharing these healthy treats with their families.

Going forward into 2022, we would like to express our deep appreciation and thanks to everyone who has supported us. Together, we can help our members increase and maintain their educational, social, emotional, and physical skills by offering programs like Make Your M.A.R.K.™, Triple Play, Money Matters, and Istation. ## TRIPLE PLAY & YOGA

With the COVID-19 pandemic disrupting home and school life for many of our members, BGCA's goal was to provide a comprehensive initiative to improve kids' overall physical health and mental wellbeing. Triple Play is our targeted approach for Mind, Body, and Soul. The "Mind" encourages healthy habits that help youth understand the relationship between behaviors and health through nutrition, food choices, and other lifestyle decisions. The "Body" promotes fun with a purpose through physical fitness and skill acquisition in a noncompetitive and encouraging recreational environment. The "Soul" element of Triple Play encompasses social and emotional activities that are critical for positive youth development. By targeting each of these key areas of whole-person growth, our members have found resiliency, developed and sustained positive relationships with others, acquired a healthy self-concept, and strengthened belief in their self-worth.

We are especially grateful for our friends at the Pratyush Sinha Foundation for partnering with us for Triple Play activities through the entire pandemic, providing both virtual and in-person yoga sessions and mindfulness trainings for members and staff. This year, we all moved on a regular basis, developed mental relaxation techniques, and expanded our coping skills.


